有害物質法 B.E. 2535 (1992)の第5条第3項および第44条(1)に基づき、有害物質委員会の意見を参考にして、工業大臣は、次のように大臣告示を発する:

第1条 この告示では;

「有害物質」とは、有害物質法 BE 2535 の第 18 条第 2 項の規定による有害物質リストに関する工業省告示の付属リスト 5 に規定された物性で分類されたリスト 5.6 の有害物質を意味する。

第2条 有害物質の生産者、輸入者又は輸出者は、次のように工業省告示の遵守を免除されるものとする。

- (1)工業省告示(B.E.2555(2012)年2月1日): 有害物質の有害性分類及び伝達システム
- (2)工業省告示(B.E. 2551(2008)3月10日): 有害物質事業施設における工業省認可による有害物質貯蔵の安全を担う専門家の指定
- (3)工業省告示(B.E.2551(2008) 3 月 10 日): 有害物質の貯蔵
- (4)産業省告示(B.E. 2547(2003)9 月 30 日):製造業者、輸入者、輸出者または所有者による工業省認可の有害物質の申告。

Notification of Ministry of Industry

Subject: Exemption from compliance with Hazardous Substance Act B.E. 2535 for hazardous substances of list 5.6 under the responsibility of Department of Industrial Works

B.E. 2558 (2015)

By the virtue of section 5 paragraph three and section 44(1) of the Hazardous Substance Act B.E. 2535 (1992), the Minister of Industry, with the opinions of the Committee on Hazardous substance, hereby issues the ministerial notification as follows:

Article 1 In this Notification:

"Hazardous substance" means hazardous substance under the responsibility of Department of Industrial Works listed in List 5.6 Groups of Hazardous Substances by their Properties prescribed in List 5 which is annexed to the Notification of Ministry of Industry on List of Hazardous Substances in pursuant to the provision in section 18 paragraph two of the Hazardous Substance Act B.E. 2535.

- Article 2 Producer, import or exporter of hazardous substance shall be exempted from compliance with the Notifications of Ministry of Industry as follows:
- (1) Notification of Ministry of Industry: Hazard Classification and Communication System of Hazardous Substances B.E. 2555, dated 1st February B.E. 2555 (2012)
- (2) Notification of Ministry of Industry: Designation of a Specialized Person Responsible for Safety of Hazardous Substance Storage under Authorization of Department of Industrial Works at the Hazardous Substance Business Facility B.E. 2551, dated 10th March B.E. 2551 (2008)
- (3) Notification of Ministry of Industry: Storage of hazardous substance under responsibility of Department of Industrial Works B.E. 2551, dated 10th March B.E. 2551 (2008)
 - (4) Notification of Ministry of Industry: Declaration of the hazardous substances

under the authorization of Department of Industrial Works by producer, importer, exporter or possessor B.E. 2547, dated 30th September B.E. 2547 (2003)

This shall, thus, enter into force on the day following the date of its publication in the Government Gazette.
